



Vehicle Parking Policy for Students

Sligo Grammar School parking policy is designed to safeguard the health and safety of all persons on the school grounds. Safe driving habits should always be observed.

We encourage all students to consider alternatives to driving themselves to School. Sligo Grammar School requires all students who do drive to school to register their vehicles with the School

The following rules should be observed:

- **Parking Permits will only be issued to full licence holders**
- The student assumes all responsibility for loss or damage to his/her car, its equipment and its contents.
- Speeding, reckless operation, making excessive noise etc. on school property or near any school building will not be tolerated.
- Cars must be locked in the morning, and must **not** be entered or moved during the day without official permission.
- Students are **not** permitted to carry other passengers on school grounds. Any student who uses a vehicle to transport other students (other than siblings) will lose the privilege of parking on school grounds.
- Student car parking is available only in the **Hermitage** car park.
- Student's cars are off limits during the school day. Your car is not a locker!
- Students are prohibited from eating, smoking, sitting in or loitering around the cars parked on the school grounds.

Violation of these regulations may cause loss of parking privileges and possible disciplinary action.

Parking on the school grounds is a privilege that may be revoked on the basis of school truancy, tardiness, attendance problems or violation of other school rules and regulations.
